# 勇迎挑戰 敢於改革 A Time for Challenge, and Change

過去一年,樂施會的工作艱辛。我們遇見史無前例的重大天災 — 南亞海嘯,隨即全力進行救援及重建工作;機構內部則成立了「中國部」,配合在內地扶貧工作的擴展;我們在國際間推行的「貿易要公平」倡議運動,取得良好進展。全年,我們管理的項目(包括發展、緊急救援及災後重建、世界公民教育等工作),多達七百二十一個。

南亞海嘯救援是樂施會歷來最大型的救援工作。按人均捐款計算,香港 是全球其中一個最慷慨的捐輸地區。全球十二個樂施會投入救災,災後 首六個月,我們支援了七個國家共約一百六十萬災民渡過難關,並規劃 在未來五年,動用十九億五千萬港元推行重建項目。多個樂施會聯手工 作,旨在令公眾捐款能運用得最具效益。各個重建項目皆以有利於扶 貧、照顧兩性平等的需要、加強未來防災能力、及以具高透明度和問責 性等原則運作。

樂施會今年成立「中國部」,管理日益擴展的中國項目。工作包括農村及城市的發展項目、政策研究、倡議工作、出版書籍、推行世界公民教育等。我們把各項工作整合,以更有效地運用經驗,讓不同工作互相協力,發揮更大效益,期能影響地方及國家政策,使扶貧工作和改變不公平制度的倡議行動,獲得更大成效。

直接的發展項目能協助貧窮人提升能力,而倡議推行扶貧政策,則能加倍強化直接項目的長遠效益(參閱頁9、11、15、16有關農民及勞工生計項目)。例如,透過國際樂施會的「貿易要公平」倡議運動,愈來愈多人認識到公平貿易是有效的滅貧之道。過去一年,樂施會成功地游説數家香港企業負起「企業社會責任」;我們又積極倡議公平貿易規則,有效地影響世界貿易組織於較早前作出裁決,宣佈美國及歐洲聯盟分別對棉花及糖進行的補貼為非法,違反世貿協定。世貿第六屆部長級會議於二〇〇五年十二月在香港舉行,樂施會積極倡議有利發展中國家滅貧的農業協議,支援全球二十五億農民改善生計。

二〇〇五年若干國際活動,對滅貧尤為關鍵。在一些國際論壇上,多國領袖均聲稱將檢討他們對貧窮國家的責任,部分決定增加援助、或豁免貧國外債、支持改革不公平的貿易規則等,冒求實現聯合國定下的二〇一五年「千禧年發展目標」。在此,樂施會促請已發展國家迅速負上責任,履行承諾,讓貧窮人獲得更佳機會脫貧,權益獲得更好的保障。

我們堅持我們的工作必須達致高質素,不論發展、緊急救援、倡議、公眾教育或籌款工作均如是。因此,機構內部設立機制,確保工作的成效、提高工作的問責性和有效地向公眾交代工作成果,這本年報正是報道了過去一年的工作和財政收支情況。在此,謹盼您與我們成為長遠的夥伴,合力扶貧。我們亦謹此祝願您來年安康,基本需要與權益獲得保障。謝謝您對樂施會的支持!

Oxfam Hong Kong will remember this year for one of the largest natural disasters in known history, the formation of our China Unit, advances in the Make Trade Fair Campaign, and our 721 active projects.

The tsunami appeal was the largest in Oxfam history, and Hong Kong one of the most generous donors per capita worldwide. In the first six months after the disaster, the 12-member Oxfam family assisted some 1.6 million people in 7 countries, and the joint disaster management plan vows to make the best use of entrusted resources in a pro-poor, preparedness-based, gender-sensitive, transparent and accountable manner.

Oxfam Hong Kong's new China Unit manages the development and expansion of our work in and on China: rural and urban programmes, policy research, advocacy, publishing, global citizenship education and more. This integration will better leverage our experience, create greater synergy and capacity, and influence both local and national policy for greater impact on poverty and inequity.

While on-the-ground programmes can empower people out of poverty – see page 9, 11, 15, 16 for projects with farmers and factory workers – advocacy can multiply that effect for the long term. Through Oxfam's Make Trade Fair Campaign, more and more people are recognising that fair trade is an engine for effective poverty alleviation. Several corporations have engaged with us on Corporate Social Responsibility, the World Trade Organization (WTO) recently declared US cotton subsidies and European Union (EU) sugar subsidies illegal, and at the 6th WTO Ministerial Conference in Hong Kong in December 2005, our goal is a pro-poor agreement to assist some 2.5 billion farmers in developing countries.

The year 2005 is 'make or break' for poverty reduction: in many forums, world leaders are reviewing their commitments to increase aid, eliminate debt, reform trade rules, and meet the Millennium Development Goals of 2015, and Oxfam is urging them to act swiftly and responsibly so that poor people have better opportunities and more rights.

In all that we do – development, emergency relief, advocacy, public education and fundraising – high quality is a must, and a given: many mechanisms are in place to ensure impact and accountability, and communications such as this Annual Review exists to relay our experiences with you, our stakeholders. We hope you will always be our partner against poverty, and we wish you all a harmonious year ahead, with all of your basic needs and rights met.

#### 樂施會綜覽

樂施會於一九七六年成立,致力消減因不公義而引致的貧窮問題,探索可持續的滅貧方案。我們在香港、中國、亞洲及非洲地區,開展不同層次的工作,包括社區發展項目、災害管理項目、倡議滅貧政策、透過世界公民教育讓公眾了解貧窮及發展問題等,以有效的方法消除貧窮成因。

#### p3-4 我們到哪裏工作?工作策略如何?

曾在至少68個國家或行政區(包括香港)工作。二〇〇四至〇五年,工作地點共29個。工作策略是跟項目所在地的團體(我們稱之為「夥伴團體」)合作,與我們一起設計、推行項目、監察項目的實施;我們亦提供建議及能力建設支援。

#### p3-4 在年內推行甚麼類型的項目?

625個發展項目、59個災害管理項目、37個世界公民教育項目。合共 721個項目。

#### p5-18 二〇〇四至〇五的工作重點為何?

p5-7 海嘯救援 項目包括清潔供水、糧食救援、恢復生計、臨時居所及房屋重建、倡議救災工作須照顧性別平等及赤貧人士的需要;並擬定了未來五年的重建計劃。

p8 被遺忘的危機 去年,全球十五個地區(大多在非洲)遇上災害,但未受世人關注。樂施會支援蘇丹內戰的難民、在尼日爾、馬利、茅利塔尼亞、塞內加爾的飢荒災民。

p9-11 農村生計及貿易支援農村生計項目,游説世界貿易組織消除不公平的貿易規則。

p12-14 擴展在中國的工作樂施會擴展在中國的工作。年內推行項目包括改善貧窮農民及勞工生計的發展項目、基本服務、災害管理、性別平等、建立公民社會及世界公民教育。

p15-16 勞工 支援勞工提升權益意識、倡議制訂妥善的勞工法例,年內在中國內地及香港的工作獲得一定成果。

p17-18 性别平等及多元化把性別平等元素渗透到扶貧項目內,實行婦女賦權,年內積極參與香港的反種族歧視條例立法諮詢工作。

#### p19-20 如何讓公眾關注貧窮問題?(世界公民教育項目)

年內透過支援教師培訓、發展學校教材、籌備成立互動教育中心及出版等工作,提升公眾對貧窮及發展議題的關注,及鼓勵參與行動。

#### p21 樂施會的工作原則為何?

「以權利為本」。在此前題下,工作項目劃分為六大目標。

#### p21-26 樂施會的六大工作目標為何? (二〇〇四至〇五年的項目名單)

可持續生活的權利、獲取基本社會服務的權利、保障生命安全的權利、意見受到尊重的權利、兩性平等及多元化的權利、做負責任的世界公民。

#### p27-31 我們的經費來源為何?如何監察用款?

年內,93%的樂施會經費來自公眾捐款。監察用款指引為:行政及籌款開支不得超過機構總開支的20%、籌款成本與籌得款項的比例必須低於1:6。

#### p32-33 樂施會的組成為何?

捐款者、義工、倡議行動支持者、負責實施項目的夥伴團體、董事局 及各委員會成員、海外樂施會、機構員工。

#### p34 誰是樂施會的「夥伴團體」?

與樂施會一起合作推行項目的當地團體,包括民間組織、政府部門、 或是海外另一個樂施會。

#### OXFAM HONG KONG FAST FACTS

Founded in 1976, we address the root causes of poverty, largely factors of injustice, and seek lasting changes through ongoing community programmes, disaster management projects, pro-poor policy advocacy and public education on global citizenship. We work in Africa and Asia, including mainland China and Hong Kong.

#### p3-4 WHERE AND HOW DO WE WORK?

Oxfam Hong Kong (OHK) has supported projects in at least 68 countries /administrative regions, including Hong Kong since 1976. In 2004/05, our projects areas reached 29. We work through community groups we call Partner Organisations with whom we design, implement and monitor projects; we also advise and assist in building up the long-term capacity of the groups.

#### p3-4 WHAT DO WE DO?

A total of 721 active projects in 2004/05: 625 development projects, 59 emergency/disaster management projects, 37 development education projects.

#### p5-18 WHAT IS OUR MAIN FOCUS THIS YEAR?

p5-7 Tsunami Relief and Rehabilitation Projects include: clean water and sanitation, food and livelihood, shelters and houses, advocacy with women, people with disabilities, and the poorest. Oxfam's 5-year rehabilitation work is in place.

p8 Forgotten Crises 15 crises affecting some 29 million people, mostly in Africa, are largely being forgotten by the world. Oxfam supported people devastated by war in Sudan; and by hunger in Niger, Mali, Mauritania and Senegal.

p9-11 Rural Livelihood & Trade OHK supports many local livelihood projects, with advocacy efforts, including on changing the unfair trade rules of the World Trade Organization.

p12-14 China OHK has been expanding our work in China with a wide range of projects: livelihood projects, basic services, disaster management, gender equity, civil society and development education.

p15-16 Labour OHK supports awareness-raising on labour rights and advocacy on better labour laws. Some impact on the work in China and Hong Kong is seen.

p17-18 Gender & Diversity Gender equity and capacity-building is mainstreamed into all OHK projects, as is seen in the consultation of an anti-racial discrimination law in Hong Kong.

#### p19-20 HOW DO WE ENGAGE WITH THE YOUTH AND THE PUBLIC?

Activities in Hong Kong and Mainland China: teaching resources, teacher training for primary and secondary schools, setting up a new Interactive Education Centre, among many others, on global citizenship education.

#### p21 WHAT IS OUR APPROACH?

"Rights-based Approach", under which our work is classified into six aims.

#### p21-26 WHAT ARE OUR SIX AIMS? (PROJECT LISTS)

The Right to a Sustainable Livelihood, The Right to Basic Social Services, The Right to Life and Security, The Right to be Heard, The Right to Equity and Diversity, Global Citizenship.

#### p27-31 WHO FUNDS US AND HOW DO WE MONITOR THE FUNDS?

This year, 93% of our funding came from the Hong Kong public. Mechanisms for monitoring our funds include: the administration and fundraising expenditure cannot exceed 20% of the total annual expenditure, the ratio of fundraising costs to funds raised must be below 1:6.

#### p32-33 WHO ARE THE PEOPLE AT OXFAM?

Our donors, sponsors, volunteers, campaign supporters, organisations with whom we operate our projects, council members and association members, staff and the 12 Oxfam International members around the world.

#### p34 WHO ARE OUR PARTNER ORGANISATIONS?

This year, we supported over 250 community organisations in Asia and Africa to operate 721 projects. They may be an NGO, a government body, or another Oxfam.

在二〇〇四至〇五年,香港樂施會 推行和管理共七百二十一個項目, 當中包括香港。這些項目部分 在年內展開,部分始於較早的年份。

#### ■ 發展項目 (625個)

為改善貧窮人生計的項目,在農村或城市推行。包括社區發展、能力建設、政策倡議工作等。其中有四十個項目沒有在地圖顯示出來,因為這些項目是跨地區或全球性的。

#### ☑ 緊急救援及災害管理項目 (59個)

包括災害救援、災後重建、防災減災等工作。 其中有七個項目沒有在地圖顯示出來,這些是 跨地區或全球性的項目。

#### ★ 世界公民教育項目 (37個)

為公眾教育項目,以香港、廣州、上海及北京的青少年為對象,提升他們的世界公民意識、培養責任感、鼓勵參與改變導致貧窮的不公義制度。

#### <mark>昌 議</mark> 樂施會項目的一項重要元素

貧窮和苦難常因不公義和剝削所導致,因此,我們部分的項目內容包含政策倡議工作,包括在本地、地區和國際等不同層面, 倡議公平和有利於扶貧的政策。


#### 樂施會與夥伴團體合作

我們大部分的項目均與項目所在地的「夥伴團體」合作,由他們設計、實施項目及評估成效, 樂施會則負責監察項目實施情況、確保項目達至目標和用款得當。這些團體主要為民間組織,部分則是政府部門或海外其他樂施會。

#### 香港樂施會與國際樂施會的關係

國際樂施會是由全球十二個獨立運作的樂施會(包括香港樂施會)聯盟組成,我們經常聯合彼此的資源,以更有效地實施大型和複雜的災害救援工作或重要扶貧項目,並聯袂推行全球性倡議運動,以加強影響力。

# Where & How We Work

In 2004-05, Oxfam Hong Kong supported a total of 721 projects (some began during the year, others in previous years).

Project areas:

29 countries / administrative regions (including Hong Kong)

There are three types of projects (with the number of projects inside the brackets):

#### Development Projects (625)

Community programmes (rural and urban), advocacy efforts, capacity building to enable people to improve their livelihoods. Note that 40 projects are not displayed on the map, as they are of a global or regional nature.

#### Emergency and Disaster Management Projects (59)

Disaster relief, rehabilitation and reconstruction, preparation, mitigation and prevention. Note that 7 projects are not displayed on the map, as they are of a regional nature.

#### Global Citizenship Education Projects (37)

Global citizenship education with schools youth, in Hong Kong and Mainland China, to raise awareness, build a sense of global citizenship, and encourage action.

#### ADVOCACY

An important feature of Oxfam's projects Poverty and suffering is often caused largely by injustice and exploitation. Many of our projects aim to advocate fair and pro-poor policies at the local, regional and international level.

#### **OXFAM AND PARTNERS**

Most of the 721 projects are designed, implemented and evaluated by 'partner organisations', locally based groups with whom Oxfam Hong Kong has built a good working relationship. These partners may be non-government organisations (NGOs), small community groups, government departments, or another Oxfam. Oxfam Hong Kong monitors the programmes to ensure that objectives are met and that funds are used properly.

#### OXFAM HONG KONG & OXFAM INTERNATIONAL

A confederation of 12 independent Oxfams (including Oxfam Hong Kong) around the world, the affiliates of Oxfam International (OI) often combine resources to respond to emergencies, undertake poverty alleviation projects, and increase impact in global advocacy.

#### 樂施會長遠的承擔

在二〇〇四年底發生的南亞海嘯,為樂施會有史以來最大宗的災害救援目。我們感謝香港公眾的慷慨捐輸,使救援和重建工作得以展開。香港一〇五年六月,撥款二千一百萬元十四萬分,撥款二千一百萬元十四萬分,撥數二千一百萬元十回國際樂施會的聯合救災行動,協印度、斯里蘭卡、東國及索馬里)的與、馬爾代夫、泰國及索馬里)的以下成果:

○清潔食水及衛生項目成功防止疫症 發生,並解決災區疾病問題

- ○糧食供應令災區不至出現大規模的 營養不良
- ○協助災民恢復生計
- 興建臨時庇護所及永久房屋
- 與其他團體進行倡議,成功游説十 九個國家同意無條件終結受災國的 債項;促請災區政府關注邊緣群體 的需要

未來五年,國際樂施會將撥款十九億 五千萬元作災後重建、長遠發展及倡 議扶貧政策之用。其中,香港樂施會 撥出八千萬元參與此項工作。

#### 災後即時救援

各個樂施會在災後即時救援,香港樂施會集中 在印尼、斯里蘭卡及印度三地工作。截至二〇 〇五年六月底,我們已進行的工作包括:

#### 未來重建計劃

國際樂施會制訂了五年的受災國重建及長遠發展計劃,香港樂施會積極參與其中,並策劃了首三年的工作重點。

#### 關注性别需要

婦女受災情況較男性嚴重,女性災民亦面對特殊困難。樂施會的研究顯示,在海嘯中女性的死亡人數遠超於男性達四倍之多。導致此現象的原因眾多,其一是較少女性懂得游泳和爬樹,求生能力較弱。另有研究顯示,在臨時庇護所內,女性受到性侵犯;在某些重建項目中,女性的需要被忽視,沒有居所擁有權,年輕女孩於災後被迫早嫁等。

#### 樂施會關注到婦女的需要:

- 在重建項目中加入關注照顧婦女需要的元素,例如提供保障私隱與安全的 沐浴及衛生設施、派發衛生巾、培訓 臨時庇護所員工以防止家庭暴力、讓 更多婦女參與小額貸款計劃(婦女在 受災國通常不獲銀行批核貸款)(參看 右頁圖片故事)
- 呼籲受災國政府注意婦女死亡數字較高的事實及其影響,確保婦女有平等的機會恢復生計,及有房屋擁有權
- 呼籲傳媒在報道中關注女性的處境

#### 關注赤貧人士及 弱勢社群

貧窮人是受災最嚴重的一群,然而,他們在救援工作中備受忽略。樂施會關注最貧窮人群、婦女和殘疾人士等邊緣社群,例如:

- 在印度協助重建鹽田,為極貧困及被 歧視的勞工提供就業機會(由於他們 的房屋沒被摧毀,政府在災後並未優 先照顧他們的需要)
- ●倡議救援及重建項目須主動回應最貧 窮人群的需要
- 倡議並在推行的項目中,照顧殘疾人士的需要

#### **OXFAM'S LONG-TERM COMMITMENT**

The tsunami relief effort has been the largest in Oxfam's history. We must thank the public for their generous donations that have made our relief and rehabilitation work possible. Oxfam Hong Kong raised over HK\$100 million and has allocated, as of June 2005, HK\$21 million towards Oxfam International's programmes that have helped 1.6 million people across Indonesia, Sri Lanka, India, Burma, Maldives, Thailand and Somalia:

Provision of clean water, health and sanitation projects have ad-

- dressed outbreaks of disease and prevented epidemics
- Food programmes have prevented massive malnutrition
- Income generation schemes are helping people recover lost income
- Temporary shelters were initially constructed to assist displaced people, and construction of permanent houses are followed
- Advocacy efforts together with other groups have convinced 19 donor countries to agree to unconditionally freeze debt repayments

for tsunami-affected countries; in the local level, needs of the marginalised people such as those with disabilities, fisherfolk, women workers and schoolchildren are advocated and addressed

Over the next five years, Oxfam Hong Kong will allocate a further HK\$80 million as part of the HK\$1.95 billion effort by Oxfam International: rehabilitation, long-term development and advocacy of propoor policies.







在印尼亞齊重建新生活「若我沒有從樂施會借來六十萬印尼盾(約為四百六十三港元)應急,真難想像如何能在今年三月恢復我的紅豆餅生意。」在印尼亞齊以造餅維生的費提瑪(上圖)說。她在海嘯中失去所有,包括她的紅豆餅小工場。現在費提瑪恢復了紅豆餅生意,意味著家人和十名造餅員工獲得了生活保障。由於銀行只接受男性作貸款擔保人,因此婦女通常借不到貸款,樂施會的小額貸款計劃遂集中協助女性。單單在費提瑪居住的村莊,便有逾一百八十名婦女參加了我們的貸款項目,並自行管理業務。

Anew in Aceh, Indonesia "If I was not granted 600,000 Indonesian Rupiahs (approx. HK\$ 463) through Oxfam's small credit project, I just could not imagine how I would have been able to restart my business in March," said Fatimah, a baker who lost all of her belongings in the tsunami. She, her family members, and her ten employees have all benefited. Oxfam has directed its work to the many women who are denied bank loans as only men can be guarantors. In Fatimah's village alone, there are already over 180 women participating in the credit project, and managing their own businesses.

#### **WORK DONE**

Oxfam responded immediately to the disaster that killed over 220,000 people and displaced millions more. Oxfam Hong Kong is focusing its efforts in Indonesia, India and Sri Lanka. A summary of action as of late June 2005 by Oxfam:

SRI LANKA: 627,043 beneficiaries; INDONESIA: 358,503 beneficiaries; INDIA: 624,170 beneficiaries

WATER, SANITATION, PUBLIC HEALTH: safe water, building latrines, cleaning wells, waste management, control of disease vectors in shelters, immunisation of children, hygiene education to prevent epidemics

SHELTERS: temporary shelters, house reconstruction, promoting a 'people-centred approach' such as advocating governments to ensure that displaced people are not forced to relocate to places where they are not willing to live

EMERGENCY RELIEF: food, clothing, household items

LIVELIHOOD: new or repaired fishing boats, nets and supplies, cash grants for relief purposes and income-generating activities, cash-for-work programmes (e.g. rebuilding homes, restoring infrastructure and clearing away debris from beaches), and equipping people with new skills and job training in such areas as the coconut industry, masonry and carpentry

INFRASTRUCTURE: such as bridges and roads

GENDER CONCERNS: (see right column)

**EDUCATION:** Books, uniforms and other supplies for schoolchildren, counseling as needed

SUPPORT DISADVANTAGED GROUPS: People with disabilities, schoolchildren, women, fisherfolk

#### **WORK AHEAD**

Oxfam Hong Kong is actively taking part in Oxfam International's 5-year plan for rehabilitation and development of the affected poor regions and we are focusing on three main areas in the coming three years.

## Priority areas of Oxfam International's current five-year plan:

WATER, SANITATION, PUBLIC HEALTH: Oxfam's area of expertise with short- and long-term projects

FOOD SECURITY, RESTORATION OF LIVELIHOODS: livelihood projects such as fishing, small-scale and often home-based industries

SOCIAL SERVICES: clinics, education (e.g. school reconstruction), counseling

INTERNATIONAL ADVOCACY: work with international bodies and governments to lobby for delaying debt repayment (already achieved), removing tariffs on exports of textiles and clothing produced by tsunami-affected countries, donor countries to deliver their promised support for relief and rehabilitation

MAINSTREAMING HIV/AIDS AND GENDER: promote gender equity (see next section), address special needs around HIV/AIDS

HOUSING: temporary shelters, permanent housing, encouraging local groups to participate in construction, advocacy on resettlement policies

#### Main focus areas of Oxfam Hong Kong over the next three years:

LIVELIHOOD / INCOME: with an emphasis on coastal communities (fishing, net-mending), inland programmes such as micro-enterprises, skills training (e.g. carpentry, electrical work and plumbing)

ADVOCACY WITH LOCAL GOVERNMENTS FOR APPROPRIATE REHABILITATION POLICIES FOR DISADVANTAGED GROUPS: such as displaced people, people with disabilities, women, children and the poorest people

**DISASTER PREPAREDNESS PROGRAMMES:** such as early warning systems

#### **GENDER CONCERN**

Oxfam research indicates that the death rate of women may have been four times higher than that of men; in the villages of Aceh Besar, Indonesia, for example, only 189 of 676 survivors were female. One factor among several is that fewer women than men know how to swim or climb trees well. The research revealed reports of rape and harassment in displaced person camps, women being ignored in relief programmes and denied ownership of new homes, and teenage girls being urged or forced to marry.

#### Oxfam has been addressing women's needs by:

- Mainstreaming gender concerns in our programmes: e.g. appropriate facilities for bathing, sanitation and shelter (for privacy and safety); suitable supplies for hygiene (including sanitary pads); training with camp management staff to prevent gender-based violence; enabling more women (who often have difficulty in getting a loan) to benefit from cash grants and small credit. (See story on p6)
- Calling on governments to be aware of the disproportionate death of so many women, and possible impacts, and make sure of women's equal

- access to income opportunities and home ownership
- Calling on the media to address gender issues in their coverage

#### ASSISTING THE POOREST / DISADVANTAGED PEOPLE

Poor people were hardest hit by the disaster. Yet, during the first six months after the disaster, they have not received enough attention in rehabilitation work in some locations. Oxfam directs its work with the poorest people, women and marginalised groups such as disabled people.

- (one of the examples) Helping rebuild salt-pans in India to provide work for many labourers who are extremely poor and discriminated against, but, because their homes had not been destroyed, their needs had not been given official priority
- Urging governments and international agencies to proactively address the needs of the poorest people in their tsunami response
- Advocating addressing the needs of disabled people in rehabilitation and long-term development plans

# CRISES FORGOTTEN'

#### BY THE WORLD BUT NOT BY OXFAM

二〇〇四年底發生的南亞海嘯觸動全球,然而,同年在非洲撒哈拉沙漠以南地區,多個國家遭遇嚴重天災人禍,導致四百萬人捱餓及營養不良,但卻被世人所遺忘,極少傳媒報道與海外支援。〇四年十一月,聯合國秘書長安南就十五項全球危機(大多位處非洲)作緊急捐款呼籲,其中包括蘇丹內戰、剛果民主共和國的人民衝突及西非多國蝗蟲為患。

這些被遺忘的災害與南亞海嘯比較,所受 到的關注微不足道。就如在香港,公眾捐 輸予樂施會以援助海嘯災民達一億港元, 但回應我們發起的蘇丹危機救援呼籲,卻 不足十九萬元。越遲救援災害,救援的所 需費用便越高。

樂施會並未遺忘這些地區的受災人民。國際樂施會就蘇丹內戰進行緊急救援,包括清潔食水、衛生、健康及教育項目等,並倡議緩解衝突,聯同另五個團體,要求蘇合國安全理事會採取強硬措施,加速蘇丹的和平談判工作。樂施會在蘇丹的達爾工作,我們亦在乍得展開工作,支援工作,我們亦在乍得展開工作,支援工作,發款一百萬元。國際樂施會自〇四年七月,在西非多個遇到蝗禍的國家(包括尼用聚,等利塔尼亞、塞內加爾)接別工作,香港樂施會撥款七十八萬元支援緊急救援及生計項目。

在亞洲,喜瑪拉雅山地區年內發生雨災。 〇四年夏天,洪水掩蓋了三分二個孟加拉 國及印度最貧窮地區之一的比哈爾邦。樂 施會從速救援,然後展開生計及防災 項目。 In November 2004, the United Nations Secretary-General Kofi Annan launched an urgent UN appeal for the world's 15 worst crises affecting some 29 million people, mostly in Africa. The crises were getting little media attention, and very little financial support – in essence, they were 'forgotten' by the world. By March 2005, only about 4% of what is needed has been pledged – for Sudan 5%, Congo (DRC) 4%, and for West Africa 3%, which is why the food crisis has reached its current proportions: as of August 2005, four million people were facing starvation or malnutrition across the Sahel region.

In Hong Kong, results were similar. Oxfam had received only HK\$189,504 in donations for Sudan, despite launching a public appeal.

In December 2004, the tsunami struck. The international community responded generously: USD 500 for each individual affected, with the UN receiving USD 931,152,816 as of March 2005. In Hong Kong, donations topped HK\$100 million to Oxfam Hong Kong alone.

Back in Africa, the crises continued being crises. The reality is that it is far more effective, and cheaper, to save lives at the onset, meeting the crisis before it fully develops. With the West Africa crisis reaching maturity,

costs to save lives have tripled. The World Food Programme appeal was originally USD 16 million but by August 2005 it had risen to USD 57.6 million, while the UN consolidated appeal rose from USD 31 to USD 81 million.

All along, Oxfam International's action in Sudan has been to combine peace advocacy and disaster management (water, sanitation, health education, etc). In November 2004, Oxfam joined five other agencies to call for the United Nations Security Council to take strong action in Sudan to quicken the peace talks. During the year, Oxfam was one of the few international agencies working in all three Darfur states, where programmes reached about 500,000 people; in Chad, we have assisted another 100,000 people. Oxfam Hong Kong contributed over HK\$1million to the effort.

Oxfam International's efforts in West Africa – Niger, Mali, Mauritania and Senegal – began in July 2004. Oxfam Hong Kong contributed HK\$780,000 for relief and livelihood support.

Meanwhile, in Asia, heavy rains in the Himalayas in the summer of 2004 flooded two-thirds of Bangladesh and all of Bihar, one of India's poorest states. Oxfam Hong Kong quickly provided emergency relief and followed up with livelihood support as well as disaster preparedness programmes.

#### 支援貧窮農民

全球百分之九十六的農民(約二十五億人)居於發展中國家,貧窮人口之中的三分二來自農村,四分三低度發展國家中的工作人口從事農業。這些事實說明,農業是貧窮國家人民重要的糧食及收入來源,因此,支援貧窮國際農民生計,促進公平的農產品國際貿易,是樂施會的工作重點。年內,我們部分重要的工作包括:

在中國、亞洲及非洲推行多項可持續生計項目,開支達三千三百萬港元,重點之一是支援貧窮農民,如改善, 改善耕種技術、加強市場銷售、促

- 進獲取及管理天然資源的權利等
- ○在東亞最貧窮的國家東帝汶支援農 民及漁民技術培訓
- 就中國西南扶貧項目作成效評估, 顯示有關村民生活水平普遍提升, 如收入增加、糧食更有保障、獲得 健康服務和教育機會
- ○為二○○五年在香港召開的世界貿 易組織(簡稱「世貿」)第六次部長 級會議進行倡議工作,爭取制訂公 平貿易規則,樂施會多年來的「貿 易要公平」運動去年略見成果

#### 東帝汶

#### 自給農民及漁民能力培訓

東帝汶自二〇〇二年實施獨立後,人民逐漸從 紛亂之中恢復和平與自由,但卻面對嚴竣的貧 窮問題。國內四成人口每日收入不足美元五角 五仙(約港幣四元),他們大多數是自給自足的 農民及漁民。

樂施會於一九九九年開始在當地工作,至二〇〇一年開展長遠的發展項目,重點支援農民及漁民改善生計,至〇四年度已推行了十九個生計項目(涉款約三百八十萬港元),主要在三個地區跟當地的民間團體合作,推行項目包括增加糧食、增加收入、促進天然資源的可持續管理、技術培訓、改善社區組織及自助能力等。

○四至○五年共推行了十二個農村生計項目, 主要為加強天然資源的管理、技術培訓、綜合 發展項目等。

#### 年內部分重要工作包括:

- 培訓二十個莫巴拉地區的農民團體, 包括農林技術、再造林、改善供水、 土壤護理、農作物加工、牧牛及牧羊 技術
- 支援青年及寡婦參與畜牧及種植項目
- 鐵匠及木匠技術培訓,以助製造及保養農耕用具和機器
- 進行研究以改良玉米種植及儲存方法

#### 中國西南

#### 發展項目改善收入及糧食保障

中國西南是主要的貧窮地區,樂施會在雲南、貴州及廣西三省工作達十四年,投放款項四千萬港元,推行的項目包括改善生計的農業生產、增加收入計劃、小型基建、供水、健康服務、教育、設立社區基金、提升村民社區組織能力、災害管理及倡議扶貧政策等。

樂施會最新一項評估中國西南項目 研究報告顯示,農村生計項目有正 面成果:

- ●被調查的村戶缺糧比例下降(詳見下表)
- 被調查的村民收入較未參與扶貧項目前增加、養飼更多牲畜、新技術培訓 (如地膜技術、玉米點播技術、開拓 新品種)使農作物質素改善、向缺乏 資金的農民借出耕作用具而致收成得 以改善
- 基建設施(如公路、灌溉及供水系統) 改善村民生活
- 村民的社區意識、自我管理及組織能力較前提升

二〇〇四至〇五年,樂施會在中國、亞洲及非 洲所實施的農村生計項目超過七十個(參看頁 21,22目標一項目名單)。

#### 倡議公平貿易

#### 讓貧窮農民受惠於世貿組織

樂施會認為不公平的國際貿易規則,是造成發展中國家農民貧窮的根本原因。現時,已發展國家迫令貧窮國家開放市場,進口已發展國家的農產品,而富有國家則大量補貼其農民,令其農產品以低於成本價在貧窮國家內傾銷,貧窮國家的本地農產品自然不及競爭,致農民生

#### SUPPORT POOR FARMERS

Consider these three facts: 96% of all farmers, or 2.5 billion people, live in developing countries; two-thirds of the world's poor people live in rural areas; and three-quarters of the Least Developed Countries' workforce is employed in agriculture. Agriculture becomes the critical source of food and income for poor countries. This is why fair agricultural trade is Oxfam's major concern. Highlights of the year include:

Globally, Oxfam Hong Kong's sustainable livelihood projects totalled

HK\$33 million, with a focus on supporting farmers by improving cultivation skills, market access, and access to and management of natural resources

- In Timor-Leste, East Asia's poorest nation, we supported training with farmers and fishers
- The results of a review of our Southwest China programme reveals higher income, better food security, health and access to education
- Advocacy for fair trade rules is underway in the lead-up to the 6<sup>th</sup>

World Trade Organization (WTO) Ministerial Conference in Hong Kong, with some actions gaining impact

#### 東帝汶社區發展基金支援漁民

二〇〇四至〇五年,Behedan 區設立了一個由漁 民的資金湊成的社區基金,用以換取樂施會提供 的捕魚工具,並向漁民借出貸款。年內進行了多 宗借還款項,基金並累積至五百美元(約三千九 百港元)。漁民獲得捕魚器具及接受訓練,令漁 獲增加。

A New Community Fund in Timor Leste In 2004-05, fishers in the village of Behedan established a Community Fund Committee comprised of capital from the fishers, in exchange for fishing equipment from Oxfam Hong Kong. Several loans have been made and repaid during the year, and by the end of the year, Behedan had over USD500 in the Fund. Fishers got fishing equipment, training and hence enjoyed better harvests.

#### **TIMOR-LESTE**

## Capacity building with subsistence farmers and fishers

Timor Leste (East Timor) has realised its independence in 2002 and peace and freedom have been gradually restored from chaos, yet poverty remains. About 40 per cent of the population lives below USD55 cents a day, mostly on subsistence farming and fishing.

Oxfam Hong Kong's relief programmes started in 1999, and long-term work in 2001; rural livelihood with farmers and fishers is a core focus – 19 projects (at HK\$3.8 million) were run by Oxfam and local partners in three districts to increase and diversify food production, generate income, practise sustainable resource management, strengthen technical skills, and improve the capacity of community groups to organise and act.

In 2004-05, Oxfam's 12 projects focused on natural resource management: technical skills, training in community organisation, and integrated livelihood programmes.

#### Some highlights of the year:

- 20 farmer groups in Maubara attended training in agroforestry, reforestation, water and soil conservation, processing crops, and in raising cows and goats
- Youth and widow groups joined livestock and farming activities
- Blacksmiths and carpenters trained in making and maintaining farming tools and machinery
- Research conducted to improve maize production and storage

- tion and new crop varieties, and better harvests due to in-kind loans for farmers who lack capital, cash-loans for others to purchase equipment
- Better infrastructure (roads, irrigation, water supply, etc.) means better living conditions
- More community awareness, selfmanagement and organising

Throughout the year, Oxfam supported over 70 rural livelihood projects across China, Asia and Africa (see p.21-22 for Aim 1 projects)

However, we have also spotted short comings of our work which needs improvement, such as: analysis on the project planning and monitoring for livelihoods systems is not in-depth and comprehensive enough; and lack of well-planned strategies for advocacy to influence government's poverty reduction practices.

#### **SOUTHWEST CHINA**

Improved income and food security Southwest China is home to some of the poorest counties in China. Oxfam has supported integrated rural projects (at HK\$40 million) in 11 of these counties in the provinces of Yunnan, Guizhou and Guangxi for 14 years: agricultural production, income generation, small-scale infrastructure, water systems, health services, education, community organising, communitymanaged funds, capacity building, emergency relief and rehabilitation, pro-poor policy advocacy and more.

#### A recent review of our Southwest China Programme reveals good impact of rural livelihood projects:

- Fewer households are being affected by food insecurity in the researched project areas (see table in next column)
- More income, more livestock, better quality of crops due to training of new technology such as plastic sheeting and sprinkle planting in maize produc-

#### **ADVOCACY**

#### For fair trade rules. Make WTO work for poor farmers

Oxfam objects to the unfair international trade rules which are a major cause of poverty for farmers in developing countries. As it stands now, developed countries are forcing poor countries to open their markets, and are then dumping subsidised crops – this is putting millions of people at risk.

Oxfam's advocacy is widely credited by policy-makers for making Northern subsidies and dumping key issues in WTO negotiations. Two recent WTO rulings have bolstered Oxfam's Make Trade Fair campaign: in the Spring of 2005, the WTO declared US cotton subsidies and EU sugar subsidies illegal – they must stop dumping or face possible sanctions, and they must compensate affected countries.

With the Sixth WTO Ministerial Conference in Hong Kong in December 2005, Oxfam Hong Kong has been undertaking many advocacy and education activities:

#### In Hong Kong:

- Liaise with Government on how to have an equitable, accountable, participatory and transparent conference
- Public education trade issues: website, books, teaching materials, etc
- Co-organised a regional conference on WTO and agriculture – over 60 academics, negotiators, legislators, officials, and NGO representatives attended.

#### In China:

- Support research on the impact of WTO trade rules on China's agriculture
- Dialogues with the trade officials in Geneva and the Ministry of Agriculture on WTO negotiations
- Support the setting up of the China WTO Network

#### FACING CHALLENGES ON A SOLID FOUNDATION

Oxfam Hong Kong has been building a foundation in China since 1987. when our first project began. Eighteen years later, China is now our largest project country, at 31 per cent of project expenditure. As the economy grows and a global power emerges, development with equity is crucial, for although 224 million people have worked their way out of poverty over the past 25 years, 26 million farmers remain in absolute poverty. China is emerging as a global power, and success in its poverty reduction and development with equity is important. China's new leadership has shown commitment to reduce poverty, to lessen the ruralurban divide, and has created a better environment for NGOs like Oxfam to strengthen and expand its work in China. Oxfam's priority areas in 2004-05:

- 382 projects on sustainable livelihood, disaster management, basic services, gender equity, equitable trade, civil society and global citizenship, in which
- 55 projects with farmers and workers on livelihoods, including to reduce rural tax, and
- 16 disaster management projects,



such as rebuilding damaged schools and houses with survivors of floods, mudflows, landslides, snowstorms and earthquakes in Yunnan, Guizhou, Guangxi, Gansu and Hunan

- Promoting the development of participatory civil society by enhancing NGOs' capacity on financial manage-ment, and helping build a suggested framework for NGO legislation
- A restructuring to expand Oxfam's work in China

#### 改善生計

#### 支援農民提升自我發展能力

農民和工人是中國主要的貧窮人群。為支援貧 窮農村脱貧,樂施會的綜合發展項目重視培訓 社區的自我發展能力、農民賦權及倡議扶貧政 策,從根本著手解決問題。

#### 年內,農村工作部分成果計有:

- 加強農戶直接參與及監督扶貧項目
- 協助貧窮社區了解政府政策,以提高 社區爭取外部資源的能力
- 就雲南、貴州及廣西十一個縣的發展項目進行評估,顯示村民的生計有所改善,社區自我發展意識及管理能力提升(詳見頁9「農村生計及貿易」一章)
- ●推行十個解決農村税費負擔問題的項目,包括就税費改革進行研究、倡議鄉鎮體制改革、舉辦滅貧與鄉村領導問題會議等

除了農村工作,我們關注內地民工的權益及生計,並長期留意內地貧農的生計如何受到中國加入世貿的影響,以配合跟進工作(詳看頁15「勞工」及頁9「農村生計及貿易」)。

#### 基本服務

#### 關注基本所需

教育、健康項目、清潔食水、衛生、安全居所 等,是基本服務的要項,年內較重要的工作發 展為愛滋病問題及基礎教育。

#### 部分工作成果:

支援成立紅絲帶協會,培訓愛滋病感染者成為健康督導員,協助防治工作、參與修路及農村生產自救、改善農村衛生、感情支援等,受益感染者及家屬約四千人

- 支援婦女愛滋病自願諮詢和檢測服務,逾四百名婦女參與
- ●實施十四個教育項目,包括重建學校、教師培訓、倡議政府落實基礎教育、爭取在甘肅蘭州居住的民工子女可以入讀國立學校接受免費教育
- ●成功在陝西省丹鳳縣毛里崗鄉東溝村開展形同保險計劃的「合作醫療」制度,解決醫療費昂貴問題。在西南地區的項目有培訓村醫、婦科病普查、興建衛生室、健康教育等

#### 性别平等

#### 根除貧窮成因

女性是貧窮人口中主要的一群,性別不平等造成資源分配不公,是婦女貧窮的根由。樂施會協助婦女提升自我組織能力、倡議她們參與制訂扶貧政策。

#### 年內部分工作有:

- ●實施十二個專注促進性別平等的項目,包括農村婦女賦權、防禦針對女性的暴力、協助決策者及公眾提高性別平等意識、支持婦女團體進行網絡聯繫、資助她們參加國際會議進行交流
- 支援河南一個農村婦女手工藝團體, 讓他們藉此工業增加收入、提升社會 地位及參與社區發展
- 籌備成立樂施會支持的男性施暴者小 組,提升性別平等意識

#### 建立公民社會

#### 支援民間團體發展

樂施會相信, 貧窮人的意見應受重視, 他們有權參與決策, 因此支援民間團體發展是我們的重要工作。年內的工作包括培訓、支援組織發展、小型項目及支持使用萬維網技術等。

#### 去年部分工作及成果包括:

- ●支援民間團體提升財務管理能力
- 經過培訓及組織支援後,有關團體更 清晰自身的使命、責任和困難
- 支持有關民間組織法規的研究,爭取 制訂健全法律,及支援研究人員和官 員到國外就民間組織法規進行交流

#### 世界公民教育

自二〇〇一年起,樂施會開展在國內的世界公 民教育工作,讓年青人認識貧窮和發展議題, 從而參與行動,建設公平社會。

#### 部分重點工作包括:

- ●在上海、北京、廣州三地進行有關教師培訓、發展教材、支援青年人參與國際會議、國外考察、出版書籍
- 進行協作者培訓,發揮互動教育效用
- 支持近二十名上海中學生及老師到泰國,考察自由貿易對農民帶來的衝擊

#### 內部重組迎挑戰

#### 擴展中國的工作

為配合擴展在中國內地的工作,樂施會重整內 部架構:

- ●成立中國部
- ●把中國的工作重整為三類:一、農村 生計;二、環境及災害管理、基本教 育、衛生及健康;三、性別平等、民 間組織發展、愛滋病及勞工權益

家人是雲南省鶴慶縣松坪社區的村民。雖然他和 當地農民每天辛勞耕種,但收成往往未送到市場 已經爛掉,因為該村離市場十公里遠,卻無公路 直達,辛勞只屬徒然。樂施會在該社區開展綜合 扶貧發展項目,包括協助龔伯伯所屬的松坪村建 築一條行車公路,方便村民運送農作物到市場。 車路建好後,龔伯伯可以及時出售作物(如圖中 龔伯歡喜地準備出售新鮮的收成),生計漸獲改 善。更重要的,透過樂施會支援建路的過程,鄰 村西坡村(亦為本會項目地區)的村民認識到參與 式管理的扶貧方法,於二〇〇四年親自動手興建 小路連接上述的車路,規劃和建築工作親力親 為,使他們的收成也能透過公路迅速運到市場交 易。過程中,村民成功向當地政府申請到資源。 這個鄰村學習效應,正是樂施會倡議的「自助」扶 貧模式。

我們在上述公路項目的工作夥伴是雲南省政府扶 *資辦公室。這種與夥伴、村民合作,從下而上參* 與式管理的扶貧模式,獲得當地政府積極回應, 並漸多採用於他們的扶貧工作上。

# Empowering poor farmers in Songping, Yunnan Gong Yushan, 69, and his family live in a remote mountain-

top village in Songping Village, Yun-nan Province. Like most farmers in the area, although he worked hard to grow melons, pears and other crops, produce usually rotted by the time it arrived at the market 10km away - there was no good road. Oxfam's integrated development project supported villagers to build a main road which has significantly improved people's livelihoods. The picture above shows happy Yushan is with his harvest which can now be sold in time! Through Oxfam's participatory approach of partnering with villagers, villagers in the neighbouring village, Xipo, also an Oxfam project site, learnt to build a small road in 2004, to link up the main road. Collaboration with the provincial Poverty Alleviation Office, Oxfam's partner in this project, has brought good feedback from many government officials who are now exploring bottom-up participation in their own poverty reduction projects, too.

#### LIVELIHOOD

#### Empowering farmers' self-development

Farmers and workers form a core group of China's poor population, and to address the root casues, Oxfam develops integrated development programmes emphasising community organisation, empowerment, and pro-poor policies.

#### Some major efforts in rural areas:

- Enhance direct participation and monitoring of projects by farmers
- Empower poor communities to understand government policy and to advocate for resources
- Impact studies of Oxfam projects in Yunnan, Guizhou and Guangxi, assessing improved income, diet, health, infra-structure, more community awareness and self-management (see p.11 on RURAL LIVELIHOOD AND TRADE)
- 10 projects on exorbitant rural tax: research on tax reform, township government reform, forums on poverty and village leadership, and related advocacy

Oxfam also supports basic labour rights (see p.16) and advocates fair World Trade Organization rules (see p.11 and p.16) - both of which can help ensure a livelihood.

#### **BASIC SERVICES**

#### For well-being

Education, health care, clean water, sanitation and better housing are the focus areas, with an emphasis on HIV/AIDS and basic education.

#### A few highlights include:

- Support the setting up of Red Ribbon Association which trains HIV-infected people as health supervisors, over 4,000 patients and their families have benefited from services such as treatment and prevention of the disease, emotional support, community hygiene, road-building and farming
- Support voluntary HIV/AIDS consultations and tests with 400 women
- Launch 14 education projects, including school rebuilding, teacher training and advocacy for basic education for all, including for children of migrant workers in cities
- Support doctor training, women's health check-ups, health education, building clinics in southwest China, and setting up a rural cooperative health care system in Shaanxi

#### **GENDER EQUITY**

#### A key to poverty reduction

Women are another major group of poor people, with gender inequity a root cause of poverty. Oxfam helps empower women, and enables them to take part in policymaking which can ensure their basic rights.

#### Some highlights:

- 12 gender projects on empowering rural women, preventing violence against women, raising awareness of the public and of policy makers on gender equity, supporting networking of women's groups and funding them to attend international conferences for capacity building.
- Support the launch of a women's handicrafts group in Henan to raise income, status and participation in community development
- Preparation of the Oxfam supported men's group of ex-batterers, to promote gender equity

#### **CIVIL SOCIETY** BUILDING

#### Poor people's voice heard

Oxfam believes that poor people must participate in poverty reduction, that their opinions must be heard. During the year, we supported the development of Non-Government Organisations (NGOs) through training, support in organisational development, small grant programmes and utilising internet technology, among others.

#### Some of the efforts and impacts:

- Financial management skills of NGOs have been strengthened
- Grassroot groups Oxfam supports are more aware of their mission, responsibilities and challenges
- Research on legislation conducive for NGO development, researchers and officials were supported for exchanges on NGO legislation models in other countries

#### **GLOBAL CITIZENSHIP EDUCATION**

Since 2001, Oxfam has supported education with youth to raise their awareness and encourage them to assume responsibility for their choices in life.

#### Some efforts in the year:

- 11 projects in Shanghai, Beijing and Guangzhou, on teacher training, materials, youth participation in international conferences, a study trip and book publications
- Training for Trainers to promote interactive development education
- Support 10 Shanghai secondary students and eight teachers to visit Thailand to see how free trade is affecting longan farmers

#### RESTRUCTURING FOR **EXPANSION**

To cope with the expansion of our work in China, Oxfam Hong Kong has re-organised our structure and management:

- A China Unit has been set up
- Three main clusters: 1. Rural livelihood; 2. Environment and Disaster Management, and Basic Education and Health; and 3. Gender, NGO development, HIV/AIDS and Labour

#### 權益保障生計

#### RIGHTS SECURE DIG-NITY AND LIVELIHOODS

One fifth of the world's 2.8 billion nonagricultural workers live in absolute poverty, earning less than one US dollar a day, and many work at risk: over 2 million deaths each year from occupational diseases or accidents.

Oxfam Hong Kong launches various programmes to:

- enhance awareness of workers' rights
- advocate better labour law
- Ourge governments to enforce labour law
- raise public concern about trade practices that infringe labour rights

#### 中國

#### 提高權益意識、支持法援、培訓

在中國,數以億計的工人每天推動著這家世界工廠運作。大量農民進城打工,亦藉此脱貧。不過,工人的權益卻受剝削:長期超時工作、工傷和職業病個案頻生、索償困難……。全國八千萬名非正規勞工如家政工(家庭傭工),更因沒有簽訂合約而基本權利不保。

只有小三學歷的小麗從山西到北京當褓母,每 天工作十二小時,沒有休息日,月薪僅得一百 五十元人民幣,還經常受到主人虐打。

樂施會在北京的工作夥伴團體「打工妹之家」介入,支援小麗告上法院,並獲勝訴,可獲賠償 共四千多元人民幣,惜僱主一家早已遠走國 外,她不獲分毫。

樂施會支持民間組織為工人提供免費法律諮詢 和援助服務,協助他們追討工資和賠償,並資 助培訓工作,提高工人權益意識。

#### 年內,樂施會的工作成果包括 (涉及全國至少七個省市):

- 支持法援團體共處理超過三百八十個 法援個案、協助逾八百名工人、追回 賠償近三百六十萬元人民幣
- 支持民間組織的培訓及倡議活動,服 務逾十萬工人
- 支持全國首個非正規就業工人工會── 家政工工會在西安成立
- 與政府部門、民間組織及學術機構合作,促進改善勞工法例及勞動爭議處 理程序

#### 香港/中國/全球

#### 「反轉件衫睇清楚」倡議運動

在香港,我們推出「反轉件衫睇清楚」倡議運動 (國際樂施會「貿易要公平」運動的一部分),呼 顧成衣業界改善採購模式,尊重工人基本權 利。樂施會年內發表的報告顯示,成衣品牌公 司或訂貨公司在全球化的競爭下,不斷壓低工 廠單價,縮短交貨期,以致工人薪金不斷下 跌,並嚴重超時工作。

我們舉辦了連串街頭展覽、收集簽名;到中學和大學舉辦講座及工作坊;製作教材、出版物和「企業社會責任資源手冊」;同時向企業和商會展開游説工作。

#### 工作取得初步成果:

- 部分公司答允讓勞工團體在國內的工 廠舉辦培訓課程,加深工友權益意識
- 不少公司主動索取「企業社會責任資源手冊」,德國一零售貿易商會更以 此培訓其員工

#### 香港

#### 跟進外判工情況

外判清潔工受到剝削仍是我們的關注點。政府在〇四年實施了樂施會及夥伴團體共同倡議的保障工人合理工資政策後,仍不時發生承辦商非法剋扣工資及假期等事件。

#### 樂施會與工會繼續跟進, 工作及成果包括:

- 向有關政府部門反映侵權情況,把涉及刑事罪的個案轉介警方
- 房屋署主動收緊對承辦商的監管措施

#### **CHINA**

#### Raise awareness, support legal aid and training

China's economic reforms have encouraged tremendous rural-urban migration, which has led to a massive workforce. Yet, the rights of millions of these workers are being infringed: unpaid overtime, an increasing number of occupational accidents and diseases, and difficulty in being awarded compensation. Nearly 80 million informal workers – most of whom have no contract – are not guaranteed even a minimum level of protection.

Xiao Li, 15, left her village in Shanxi to work as a baby-sitter in Beijing. On top of working 12 hours a day, 7 days a week, and earning only RMB 150 (approx. USD18) a month, she was constantly abused by her employer –physically and psy-chologically. Migrant Women's Club, an Oxfam-supported organisation, supported Xiao Li to bring her case to court. She 'won'

and was en-titled to receive over RMB 4,000 in compensation, but her employer had fled the country.

Oxfam supports many local groups across China to provide workers with legal aid, training, and an awareness of their rights.

#### Some achievements in 2004/05:

- Two Oxfam-assisted legal organisations helped win RMB 3.6 million in compensation for over 800 workers
- More than 100,000 workers joined Oxfam-supported training and advocacy pro-grammes
- The first trade union for informal workers in China, Domestic Workers Trade Union, was established in Xian with Oxfam's support
- Engaging with government, community groups and academic institutes, Oxfam advocated better laws and procedures to settle labour disputes

## Let's turn the garment industry inside out

The focus of Oxfam's Make Trade Fair Campaign in 2004 was to urge the garment industry to improve their purchasing practices and respect basic labour rights: too often, brand or sourcing companies push suppliers on price and speed, resulting in increasingly difficult working conditions. A 2004 study commissioned by Oxfam Hong Kong revealed an average of 150 overtime hours in some Hong Kong-owned factories in Guangdong; labour law only permits 36 hours of overtime. Oxfam's campaign included exhibitions, a petition with signatures, seminars, workshops, advocacy with companies and chambers of commerce, and publishing Resource Kit on Corporate Social Responsibility.

#### Impact of our work includes:

- Some companies agreed to allow labour groups to launch more training and awareness projects in their factories in China
- A German trade association adopted Oxfam's Resource Kit on Corporate Social Responsibility for employee training

#### HONG KONG

#### Improving conditions for sub-contracted workers

Oxfam is concerned about the exploitation of workers on government-out-sourced contracts, such as cleaning workers of public housing estates. While the government adopted suggestions advocated by Oxfam and other local groups to safeguard a reasonable wage, we still receive reports of contractors illegally withholding wages, holidays and other entitlements.

## Continued advocacy work and impact includes:

- Effective communication with government and referring suspected criminal cases to the Police
- The Housing Department has improved the monitoring of their contractors' conditions for employees

#### 平等權利

#### 在農村建立平等社會

#### 雲南經驗

在中國,男性往往控制了資源和決策權,使女 性處於被支配的地位。樂施會在中國推動性別 平等的主要工作包括提升婦女組織能力及減少 針對女性的暴力。在雲南省祿勸縣半坡社區, 樂施會支持一群苗族婦女的自助組織,協助她 們有效地解決區內婦女受虐、自殺和女性貧窮 問題。其工作成果包括:

- ●減少婦女自殺個案(由二○○二年的 五宗,減至翌年七月○宗舉報個案)
- ■實施方法以防止男性酗酒而虐待妻 子,包括由村民訂立規則以限制男性 飲酒量、設立臨時住所供醉酒男村民 入住、輔導酗酒的男村民
- 支援貧窮婦女的社區項目:設立太陽 能環保浴室以改善婦女衛生、婦女基 本醫療訓練、培訓婦女分辨假貨幣、 協助孤寡、殘疾及年長婦女耕作

#### 在城市建立平等社會

#### 香港經驗

性別與種族歧視在香港固已有之。從中國內地 來港的新移民,許多生活在貧窮線以下,其中 多為婦女;南亞族裔的居民亦在就業和就學上 遭受歧視。

#### 樂施會在年內的主要工作包括:

- 出版《性別平等主流化之民間團體經 驗報告》,為香港民間組織推動性別 平等的工作提供有用資源
- 約五十名自助組織管理人員參與樂施 會舉辦的性別平等工作坊
- 促請教育當局把性別平等課題結合到 學校課程內
- 出版書籍《76.8%的天空》探討香港的 女性貧窮問題及《小童·大同-香港 少數族裔兒童的世界》報道香港少數 族裔兒童的生活
- 與廿三個團體合作,成功游説政府延 長有關草擬反種族歧視條例的公眾諮 詢期

#### 在全球層面 推動性别平等

樂施會參與全球性的倡議工作,並在我們的救 災項目中留意性別平等的原則。

#### 年內重點工作包括:

- 支援中國及柬埔寨的婦女團體參與紐 約「北京加十」世界婦女大會,回顧過 去十年改善全球婦女權益的進展,參 加者表達意見、交流工作經驗及促進 聯繫
- 樂施會的研究發現在南亞海嘯中,女 性死亡人數遠超男性,而在救援和重 建工作中,婦女亦面對安全保障問 題,因而在我們的救災及重建項目 中,採取措施關注女性需要、平等參 與和決策權(詳見頁7);在蘇丹危機 的救援中,亦包含性別平等元素

# 加強機構內部

過去十年,樂施會逐步加強內部機制,期能在 所有扶貧項目中滲透性別平等元素。年內為加 強這項工作,我們設立「性別平等政策主任」一 職,協助確保內部各項工作邁向性別平等的機 構目標,包括在發展及災害管理項目、政策倡 議、世界公民教育、籌款、傳訊及人事政策等 各方面的工作上,體現性別平等原則。







#### **EQUITY FOR ALL**

Women and minorities are two distinctly marginalised groups. Too often, females are denied education, land rights and threatened with domestic violence. Statistics show that 70 per cent of the world's poor people are women. Oxfam Hong Kong strives to help create more equitable communities by some highlighted efforts:

 All projects aim to integrate gender components while 56 projects specifically addressed gender,

- ethnicity and disadvantaged people (see Aim 5 list, p.25-26)
- A rural project in China supported women to organise into groups to address wife abuse, womens suicide and female poverty
- Enabled women's groups to advocate at the United Nations 'Beijing + 10' conference in New York
- Adopt a new internal mechanism to improve the mainstreaming of gender equity into all programmes
- Publish books to reveal gender in-

- equity and racial discrimination in Hong Kong
- Make recommendations to Hong Kong SAR Government on their proposed anti-racial discrimination law and encourage community consultation

#### IN THE VILLAGE – YUNNAN

#### Organise against abuse and suicide

Building up women's capacity and reducing domestic violence against women are two of Oxfam's programme areas in China. One group of Miao women in a village in Yunnan Province organised themselves, with Oxfam's support, to effectively tackle two genderbased problems: wife abuse and women's suicide. In fact, women's subordination to men (who usually control resources and decision-making) is a root cause to female poverty. Here is a summary of the group's achievements:

- In 2002, five women in this village attempted suicide; yet after the women's organising, no suicides have been reported since July 2003
- Wife abuse caused by male drunkenness was addressed by setting up rules to limit liquor intake, providing a temporary place for drunk men to stay, and discussing the violence at village assemblies
- Community-wide projects: a solarpowered public bath; basic women's health training; training women to distinguish counterfeit money; farming projects with widowed, handicapped and elderly women

# IN THE CITY – HONG KONG

#### Equity for women and minorities

Discrimination by gender and ethnicity is a reality in Hong Kong, where most women from Mainland China are in poverty. Minority groups from South Asia face unfair treatment at school and at work. Highlights of Oxfam's efforts are:

- Oxfam's 'Gender Mainstreaming NGO Experience' Report serves as a useful tool for NGOs
- 50 leaders of self-help groups attended Oxfam-supported workshops on gender equity
- Advocates education authorities to integrate gender equity into the curriculum
- 76.8% of the Sky Gender, Poverty and Development in Hong Kong, a two-volume book (in Chinese) reveals local women poverty, and the book, Kids Alike – A World of Children in Hong Kong presents the lives of minority children
- Oxfam and 23 other groups succeeded in lobbying the Government to extend the deadline for the public consultation on the proposed legislation on racial discrimination

#### AROUND THE WORLD

#### Gender-fair development and relief

To promote gender equity, Oxfam supports global advocacy and gender-fair emergency response. Some highlights during the year:

- Oxfam supported women NGOs from China and Cambodia to participate in a United Nations women's conference in New York which reviewed the improvement of women's rights since 1995, and the participants expressed their views and strengthened their network
- Oxfam research revealed relatively higher vulnerability of women compared to men in the Asian tsunami, and efforts are being made to address women's needs in relief and rehabilitation programmes both in tsunami (see p.7) and in the Darfur crisis

#### **INSIDE OXFAM**

#### Practising gender sensitivity

Internally, Oxfam Hong Kong has been improving agency-wide gender policies over the past decade. During the past year, we created the position of Gender Equity Policy Advisor to enable colleagues to develop better gendersensitive practices in all areas of work: advocacy, development projects and humanitarian efforts, and Oxfam's management practices.

#### 戰爭、殺戮、反思

#### WAR • DEATH • REFLECTION

伊拉克戰爭和蘇丹內戰,對年青人來說是太遙遠了,如何能感受戰亂人民的苦難,從而關懷 貧弱,共同承擔世界公民責任?

刺激的戰爭遊戲讓年青人玩得興奮, 看,大家爭相用紙飛機射殺桌上的士 兵,射中最多的便勝出。笑聲中,射 呀射……然後,每名身亡士兵背面有 個號碼,按著號碼翻查資料,發現每 個士兵都有一個故事,都有夢想。射 殺者毀滅了生命和夢想……

這是樂施會與香港中文大學社會學系、教育統 籌局和社會經濟政策研究所合辦的中學教師工 作坊,透過試玩互動遊戲,讓學生了解全球化 下的戰爭與和平。 Are the wars in Iraq and Sudan too remote for Hong Kong youngsters to relate to? Can they empathise with the suffering and act as a global citizen?

Look! Hong Kongers are very involved in this game with paper soldiers and paper fighter planes: shoot down the most soldiers to win. But behind each paper death is a tragedy. On each soldier's back is a number which corresponds to a unique life story, a life of aspirations killed by war.

In this global citizenship education workshop, The project was jointly run by Oxfam Hong Kong, the Department of Sociology of the Chinese University of Hong Kong (CUHK), the Education and Manpower Bureau (EMB) of the HKSAR Government and the Social and the Economic Policy Institute, secondary school teachers are trained to arouse students' awareness of war and conflict through interactive games.

全球走向一體化,本地與全球性的貧窮問題,必須透過各地的合作,始能解決。樂施會通過世界公民教育工作,促進年青人對貧窮及可持續發展議題的認識,鼓勵他們行動,參與扶貧工作,共同建立公平和可持續發展的世界。以下是年內的工作重點。

#### 教師培訓

樂施會跟前述戰爭遊戲的參與機構合辦中學通 識教育科工作坊,與教師探討在四個發展議題 方面的教學法,議題為:香港邊緣勞工問題、 中國加入世貿後帶來的衝擊、專利與糧食問 題、全球化下的衝突與和平。教師們探討如何 透過遊戲(例如前述的戰爭遊戲)啟發學生認識 問題,以及透過討論引導學生作深度反思。

#### 發展教學資源

樂施會與以下機構合作,發展教學資源:

中學教材套光碟:與中文大學社會學系及社會經濟政策研究所合作,內容涉及上述工作坊的四大議題。

小學教材套光碟:與香港教育學院公民教育中 心共同開發四個單元:全球化與相互依賴、多 元文化的社會、資訊科技與貧窮、國際貿易與 貧窮。

網上教學資源:樂施會教育網站「無窮校園」 (www.cyberschool.oxfam.org.hk/)提供有關貧 窮及可持續發展議題的教學資料,獲教育統籌 局向教師推介使用。

#### 籌備成立「無窮地球 ── 互動教育中心」

中心於二〇〇五年十一月啟用,為年青人提供一個以體驗為本的環境,認識貧窮和發展議題,每年為學校、青年群體提供二百個工作坊及培訓活動。中心有賴埃森哲公司捐贈港幣廿五萬元支持,該公司並邀請樂施會成為其企業公民計劃夥伴,讓員工認識貧窮問題和服務社群。利希慎基金亦支持我們在六所中學開展世界公民教育深度校本發展計劃。

#### 旅遊與貧窮考察

Today's world is so globalised that poverty must be addressed through the cooperation of people around the world. Through education on global citizenship, Oxfam Hong Kong encourages youth to develop an awareness of poverty and development, and be willing to take part in address-ing the problems. Below are some of Oxfam's major education work during the year.

#### **TEACHER TRAINING**

One Liberal Studies workshop explored teaching methods in four topics: marginalised labour in Hong Kong, the impact of WTO accession on China, the patent system and food security, and war and conflict in the context of globalisation. It was jointly organised by the four organisations which launched the workshop with the game war (see previous page). Educational games were introduced, and teachers also explored how to stimulate students' in-depth reflection on the issues through discussions.

# TEACHING RESOURCES

Oxfam helped developed these materials, among others:

# OXFAM INTERACTIVE EDUCATION CENTRE

The Centre, in North Point, Hong Kong, run by Oxfam, provides a unique experiential learning environment for young people, with about 200 activities, training sessions and other programmes each year on poverty and sustainable development. It opened in November 2005. The private sector supports Oxfam's youth education – Accenture partnered with us as part of its corporate citizenship efforts, which includes fundraising and voluntary activities with employees, and a donation of HK\$250,000 to the operation of the Centre. Lee Hysan Foundation has also supported Oxfam on an in-depth school-based development project with six local secondary schools.

# TOURISM AND POVERTY

Oxfam guided more than 30 secondary school students to see the difference between how community-based tourism and commercial tourism impact local residents. The teenagers talked with Pa-Duang Karen people (colloquially called 'Long Neck') in Thailand to know how they feel about earning an income from their unusually long necks. Students lived with ethnic minority families in remote mountain villages to witness the positive impact of alternative tourism on the community. They also visited a red light district for tourists to learn about the lives of sex workers.

二〇〇四至〇五年,樂施會共推行七百二十一個項目,包括以下三百九 十一個於此一年度內批核撥款和開展的,其餘項目則於較早的年份批核 和展開。項目分為六個目標,包括五項「權利」及第六項實踐世界公民責 任。所有項目的策略及實施,體現了樂施會對扶貧和發展工作所秉持的 原則——「以權利為本」。

#### 甚麼是「以權利為本」?

我們可以用這個比喻了解「以權利為本」的意義 — 給予受助者一條魚, 只能解決他/她一天的需要,但若教曉他/她養魚,他/她將終生不缺。 不過,他/她光有捉魚的技能,原來未足以保證他/她能享有可持續的生 計,他/她還必須有權進入漁場捕魚,並且有一個可讓他/她成功出售魚 獲以賺取生計的市場!

樂施會扶貧及發展工作的原則,參照了國際人權概念,相信 為不同人群的權力關係失衡所致,即某部分人享有更大的權 力,從而剝削弱勢人群的利益。因此,樂施會強調根除貧窮 成因,重視建立公平公義的社會制度,避免出現權力關係不 平衡的現象。我們運用綜合的扶貧方法,既向貧窮人提供基 本所需,進而協助他們提升能力,並透過倡議政策,確保貧 窮人的權利受到保障,從根本著手解決問題。

# A Rights-Based roach to

In 2004/05, Oxfam Hong Kong helped run 721 projects, with the following 391 projects newly approved with funding during the year. We divide our projects into five aims for development, and one aim on global citizenship. The strategy and implementation of these projects express a core Oxfam value: a rights-based approach to development.

#### What is the Right-Based Approach?

There is a new twist to a well-known story – giving a person a fish helps for a day; teaching how to fish and helps for a lifetime. But you do need to ensure that people have the right to access fishing areas and a market for their catch!

Oxfam's approach to development uses the international human rights platform to address poverty and development: the belief that poverty is caused, driven and perpetuated by violations of people's basic rights, and that power is the mechanism by which rights relations are determined. That's why Oxfam puts an emphasis on equity and justice to address the root causes of poverty; this prevents an imbalance of power from emerging. We integrate the provision of basic needs, the building of people's and organisations' capacity, and protecting and defending rights through policy advocacy.

#### 年內五個主要籌款項目

#### ● 樂施會非洲發展基金

這基金於二〇〇四年八月成立,旨在確保我們獲得足夠資源,讓非洲的扶貧工作持續不歇。非洲撒哈拉沙漠以南地區是全球最貧窮的地區之一,當地四成人每天收入不足一美元。去年成立這項基金,共籌得逾四十萬港元,並有二千一百八十四位人士登記成為「樂施非洲之友」,以每月定額捐款形式支援非洲的貧窮人。我們承蒙影星任達華出任「樂施非洲大使」,協助籌款。成立基金當日,任達華參與「貧富宴」、音樂創作人徐偉賢為基金作曲、非洲樂隊Mamadou演奏非洲鼓。

#### ● 樂施會中國發展基金

年內,合共一萬五千七百二十八位每月捐款者支持「中國發展基金」,讓樂施會得以在內地推行三百八十二個扶貧項目,用款共三千八百萬港元(參看頁12-14樂施會的中國項目)。藝人汪明荃頂力支持籌款工作,出任「樂施大使」。她除親身到貴州探訪樂施會的項目外,亦廣泛向新聞界介紹本會工作,協助售賣「樂施米」。每年一度的基金籌款活動獲得超過四千名人士加入成為「樂施中國之友」,每月捐款。

# **FUNDRAISING**

#### A POOL OF PUBLIC SUPPORT

Most of Oxfam Hong Kong's income – 93.2% of total income for the Year 2004-05 – comes from donations from the Hong Kong public.

We express our heartfelt thanks to the more than 120,000 people who have supported us this year, as monthly donors, Oxfam Trailwalkers participants, or in many, many other ways. Without you, Oxfam simply could not do our work against poverty and injustice.

# FIVE MAJOR SOURCES OF INCOME DURING THE YEAR

#### OXFAM AFRICA DEVELOPMENT FUND

This newly launched Fund (in August 2004) will ensure that Oxfam can continue our antipoverty work across Sub-Saharan Africa, which remains one of the world's poorest regions: 40% of the people earn less than USD1 a day. With the help of Oxfam Ambassador Simon Yan, HK\$418,043 was raised during the year, and 2,184 people registered as Oxfam Africa Partners.

#### OXFAM CHINA DEVELOPMENT FUND

Thanks to monthly donations by 15,728 Oxfam China Partners, this Fund supported 382 projects (\$38 million) across China (See p.12-14). Actress Liza Wang helped publicise Oxfam's appeal by visiting Guizhou as an Oxfam Ambassador, and joining the annual Oxfam Rice Sale in May 2004. During the year, 4,355 new Partners signed up.

#### OXFAM EDUCATION FUND

Oxfam supports basic education with children and adults, teacher training, policy advocacy and more, as education can help break the cycle of poverty. In 2004-05, 28 projects (at HK\$5.4 million) were made possible, thanks to 8,683 Oxfam Education Partners.

To help raise awareness, and funds, singer Alex Fong joined as Oxfam Ambassador, participating in our annual Oxfam Colour Pencil Sale in February 2005, and helping bring in HK\$2,286,595 and 2,241 new Partners.

#### YIU KEONG EDUCATION MEMORIAL FUND

This recently established Fund, dedicated to education projects in China, allocated HK\$500,000 this year to support the improvement of two primary schools in rural Yunnan.

#### OXFAM TRAILWALKER

This annual event has grown leaps and bounds since 1981 when the Gurkhas first held Exercise Trailwalker, for soldiers only! The event is now Hong Kong's largest sports fundraiser with almost 4,000 walkers. Oxfam Ambassador Tanya Liu, a news commentator who recovered from a train crash in 2002, was an inspiration to all at Oxfam Trailwalker 2004: three records were broken! HK\$23,275,000 was raised, 11hrs 57min became the fastest time ever, and 71% of teams and 88% of the 3,900 participants finished the 100km trail. A big thanks to State Street for being the title sponsor for six years now, and to the many other companies, organisations and individuals who support Oxfam Trailwalker.

#### Cost-efficiency

- The ratio of fundraising costs to funds raised must be below 1:6 (for every dollar spent, \$6 or more must be raised) – in the Year 2004/05, Oxfam Hong Kong achieved a ratio of 1:8.46. This ratio has absorbed the fundraising cost of the Tsunami appeal but excluded its income. (See p.31 – Tsunami's I/E table).
- The maximum administration and fundraising expenditure is 20% of the agency's total annual expenditure – in the Year 2004/05, this was 18.49%, excluding Tsunami project expenditure.







大學社工系學生袁家怡,對貧窮人的關懷及發展議題的興趣,是爸爸多年身教的成果。「爸爸常說,我們要貢獻社會,幫助有需要的人,因為這是公民責任。」

耳濡目染之下,袁家怡年紀輕輕已積極助人,一年多前更成為樂施會每月捐款人一「樂施之友」。年齡漸長,她理解到扶貧工作不是「單純的捐錢助人那麼簡單」。因此,她藉著當駐校實習社工及課餘替學生補習的機會,以樂施會刊物《無窮》為敎材,向學生講解各種發展議題,盼能讓學生學習課堂以外的另類知識,從而關心弱勢社群。

Jeanette Yuen, a University student of Social Work, became interested in poverty and development because of her father. "He thinks it is the responsibility of every citizen to contribute to society," she said.

Jeanette has been a good example – in fact, she is enthusiastic! Last year, she joined Oxfam's monthly donation scheme and became an Oxfam Partner. But she understands that poverty alleviation is about more than just "giving money". WARM HEARTS WITH THE GLOW OF DIAMOND

2005年3月14日,一封沒有署名的信函,將一枚耀目的鑽石戒指(圖)寄到樂施會,並留下字句:「希望幫助有需要的人。」戒指主人胡小姐,原來去年因患了腸癌,曾動過一次大手術。「那時剛悉噩耗,須即時入院,適逢發生南亞海嘯,我希望能為災民做點事,腦海中即時想起了樂施會。」遭逢巨變,令胡小姐對不幸人群的苦難,更能感同身受。

胡小姐慷慨助人,手頭卻不鬆動,隨著病情惡化,她急於 將住宅出售,以套現治病。在此情況下,她仍願意把自己 僅有的與人分享,這種在困厄中不忘助人的精神,就像她 的鑽戒一樣,在春日的陽光下閃出動人光采。

On 14 March 2005, Oxfam Hong Kong received a letter with a diamond ring enclosed. An unsigned note read: "I hope it helps people in need."

The ring belonged to Ms Wu, who had been diagnosed with cancer of the colon last year. She told Oxfam, "After I had surgery, the devastating tsunami hit South Asia. I wanted to do something, and Oxfam immediately came to mind."

Despite Ms Wu's generosity, she was in fact in financial difficulty and had to sell her apartment for the cancer treatment. The will to help others during her own life crisis is commendable. Shiny as a diamond ring, her glow warms the hearts of many.
